RECOMMENDED BY-LAWS CHANGES

The PSC Board and the By-Laws Committee are recommending that the following changes be made to the By-Laws in the December Business Meeting.

These changes are being presented to the PSC general membership for consideration. The proposed changes include clarifications and suggested changes to the current by-laws. Each proposed change has been numbered and includes a short rationale. The by-law section for each proposed change is referenced. Any item to be deleted is indicated with a ~~strikethrough~~ and any item/word to be added is indicated by **red letters**. members are encouraged to review the proposed changes and attend the Christmas Party on Saturday, December 4 at the 6:30pm Business Meeting to consider this change. Please refer to the current by-laws from the club website as they will not be provided at the meeting. Members are encouraged to bring this attachment and a copy of the by-laws to the meeting if there are any questions before the changes are voted on.

Proposed Change # 1

Rationale: This item makes an addition to the Board of two (2) Directors-at-Large. This allows two (2) additional members of the Club to be elected to be on the Board. These 2 Directors shall assist both in the workload and the direction of the Club. It also requires officers and directors to not be officers or directors for any other Shag Club.

ARTICLE V. ~~OFFICERS~~ BOARD OF DIRECTORS, Section 1 OFFICERS AND DIRECTORS

(The Next Section was moved from ARTICLE VI: COMMITTEE SECTION 1: EXECUTIVE BOARD except for the words in red below.)

The officers of the Club shall be President, Vice President, Secretary, Treasurer and Sergeant-at-Arms. The directors of the Club shall be two (2) elected "at large" members.

All corporate powers shall be exercised by or under the authority of, and the business and affairs of the corporation shall be managed under the direction of the Board.

A quorum at any regular or special Board meeting shall be three members.

Regular Board Meetings shall be held at least every other month on a date to be decided by the Board at its first meeting after the election.

Notice is not required for regular Board meetings.

A special Board meeting can be scheduled by the President or upon the request of two members.

Notice must be given to all members, and it may be given by mail, email, or fax, upon not less than 2 days' notice and such must include the subject matter of the meeting.

Any meeting of the Board can be held in person, by phone, by fax, by email or by video conference.

Action can be taken by the Board upon a quorum voting on any matter in person, by phone, by fax, by email or by video conference. The officer in charge of same shall reduce such action to writing and provide a copy of such to all Board members within five days of such action.

SECTION 2: QUALIFICATION AND TERM OF OFFICE

Any Club officer or director prior to election must have been a) a member in good standing for at least two (2) years immediately prior to running for office or b) a member in good standing for at least one (1) year during which such member actively served on a standing club committee immediately prior to running for office. Officers and Directors of Palmetto Shag Club shall not hold an office or be a director in any other Shag Club. The Club officers and directors shall be elected yearly to serve from January through December. Each officer and director shall hold office until his/her successor has been duly elected or appointed due to a vacancy. Each officer may serve for a maximum of two (2) consecutive terms in that office.

SECTION 3. NOMINATION AND ELECTION OF OFFICERS AND DIRECTORS

Candidates for officers and directors shall be elected...

Additional nominations for officers and directors may be made from the floor at the annual meeting.

After nominations are made, then the nominations will close, and a vote will be taken for the election of ~~each~~ officers and directors. ~~starting with the president, and continuing down the above list until all such officers are so elected.~~

If there are nominations from the floor for officers or directors other than these presented on the slate, the elections shall be by secret written ballot.

SECTION 5. COMPENSATION

Board Members ~~Officers as such~~ shall not receive any compensation for their services.

SECTION 6. DUTIES

DIRECTORS-AT-LARGE

The Directors-at-Large shall perform the general duties assigned to the Board, including but not limited to service as Committee Chairs and to provide viewpoints during policy discussions of the Board, to support and/or attend Club functions and events, and to perform all other duties as may be assigned by the President or the Board.

ARTICLE VI. COMMITTEE

(ARTICLE VI: COMMITTEE SECTION 1: EXECUTIVE BOARD is deleted since it has been moved to ARTICLE 5: BOARD OF DIRECTORS)

~~SECTION 1. EXECUTIVE BOARD~~

~~All corporate powers shall be exercised by or under the authority of, and the business and affairs of the corporation shall be managed under the direction of the Executive Board.~~

~~A quorum at any regular or special executive Board meeting shall be three members.~~

~~Regular Executive Board Meetings shall be held at least every other month on a date to be decided by the Executive Board at its first meeting after the election.~~

~~Notice is not required for regular Executive Board meetings.~~

~~A special Executive Board meeting can be scheduled by the President or upon the request of two members.~~

~~Notice must be given to all members, and it may be given by mail, email, or fax, upon not less than 2 days' notice and such must include the subject matter of the meeting.~~

~~Any meeting of the Executive Board can be held in person, by phone, by fax or email.~~

~~Action can be taken by the Executive Board upon a quorum voting on any matter in person, by phone, by fax or email. The officer in charge of same shall reduce such action to writing and provide a copy of such to all Executive Board members within five days of such action.~~

Proposed Change # 2

Rationale: The current wording of the by-laws requires that vacancies be filled by election within 60 days of a vacancy. This is not practical based on the infrequency of our Parties and Meetings because nomination and election requirements in the by-laws. Therefore we would propose that the Board appoint a qualified member to fill any vacancy for the remainder of the unexpired term (less than 1 year).

ARTICLE V. ~~OFFICERS BOARD OF DIRECTORS,~~

SECTION 4. VACANCIES

~~Any office which becomes vacant before December will be filled by special election of the general membership within sixty (60) days of the vacancy. If any member of the Board is unable to complete their term, the Board will appoint a replacement to fill the unexpired term.~~

SECTION 6. DUTIES

~~TEMPORARY OFFICERS~~

~~The Executive Board shall have the authority to appoint any qualified member to temporarily fill any vacancy in any office, with the person so appointed to so serve until the position is filled on a permanent basis. No such appointment shall last for more than 30 days, but may be extended for an additional 30 days if for some reason a permanent replacement has not been elected.~~

Proposed Change # 3

Rationale: Miscellaneous Clerical Changes

Clarified all mention of Members and Associate Members in the document. In the past there was usage of both General Members, Members and Associate Members and in some instances, it was not clearly worded. This was corrected in numerous locations.

Inclusion of Video Conferencing as a communication method, numerous locations

Made all references to Executive Board, Executive Committee and Board to all be made consistently as Board in numerous locations.

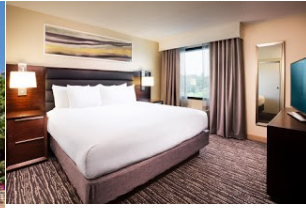
